# Online Safety & Acceptable Use Policy Ratified by Governors Review November 2025

#### 1. Aims

Our school aims to:

- Have robust processes in place to ensure the online safety of pupils, staff, volunteers and governors
- Deliver an effective approach to online safety, which empowers us to protect and educate the whole school community inits use of technology, including mobile and smart technology
- Establish clear mechanisms to identify, intervene and escalate an incident, where appropriate

#### The 4 key categories of risk

Our approach to online safety is based on addressing the following categories of risk:

- **Content** being exposed to illegal, inappropriate or harmful content, such as pornography, fake news, racism, misogyny, self-harm, suicide, anti-Semitism, radicalisation and extremism
- **Contact** being subjected to harmful online interaction with other users, such as peer-to-peer pressure, commercial advertising and adults posing as children or young adults with the intention to groom or exploit them for sexual, criminal, financial or other purposes
- Conduct personal online behaviour that increases the likelihood of, or causes, harm, such as
  making, sending and receiving explicit images (e.g. consensual and non-consensual sharing of
  nudes and semi-nudes and/or pornography), sharing other explicit images and online bullying;
  and
- Commerce risks such as online gambling, inappropriate advertising, phishing and/or financial scam

#### 2. Legislation and guidance

This policy is based on the Department for Education's (DfE) statutory safeguarding guidance, <u>Keeping Children Safe in Education</u>, and its advice for schools on:

- Teaching online safety in schools
- Preventing and tackling bullying and cyber-bullying: advice for headteachers and school staff
- Relationships and sex education
- Searching, screening and confiscation

It also refers to the DfE's guidance on <u>protecting children from radicalisation</u>.

It reflects existing legislation, including but not limited to the <u>Education Act 1996</u> (as amended), the <u>Education and Inspections Act 2006</u> and the <u>Equality Act 2010</u>. In addition, it reflects the <u>Education Act 2011</u>, which has given teachers stronger powers to tackle cyber-bullying by, if necessary, searching for and deleting inappropriate images or files on pupils' electronic devices wherethey believe there is a 'good reason' to do so.

The policy also takes into account the National Curriculum computing programmes of study.

## 3. Roles and responsibilities

#### 3.1 The Governing Body

The governing body has overall responsibility for monitoring this policy and holding the headteacher to account for itsimplementation.

The governing body will co-ordinate regular meetings with appropriate staff to discuss online safety, and monitor online safety. The governors who oversee online safety are Rob Kettle and Steve Martin.

All governors will:

- Ensure that they have read and understand this policy
- Agree and adhere to the terms on acceptable use of the school's ICT systems and the internet (Appendix 4)
- Ensure that online safety is a running and interrelated theme while devising and implementing whole school approach to safeguarding and related policies and/or procedures
- Ensure that, where necessary, teaching about safeguarding, including online safety, is adapted for vulnerable children, victims of abuse and some pupils with SEND because of the importance of recognising that a 'one size fits all' approach may not be appropriate for all children in all situations, and a more personalised or contextualised approach may often be more suitable.

#### 3.2 The Headteacher

The headteacher is responsible for ensuring that staff understand this policy, and that it is being implemented consistently throughout the school.

#### 3.3 The Designated Safeguarding Lead

Details of the school's DSL and deputies are set out in our Safeguarding and Child Protection policy as well as relevant job descriptions.

The DSL takes lead responsibility for online safety in school, in particular:

- Supporting the headteacher in ensuring that staff understand this policy and that it is being implemented consistently throughout the school
- Working with the headteacher, ICT manager and other staff, as necessary, to address any online safety issues or incidents
- Managing all online safety issues and incidents in line with the school child protection policy
- Ensuring that any incidents of cyber-bullying are logged and dealt with appropriately in line with the school behaviour policy
- Liaising with other agencies and/or external services if necessary

#### 3.4 The ICT manager

The ICT manager is responsible for:

- Putting in place an appropriate level of security protection procedures, such as filtering and monitoring systems, which are reviewed and updated on a regular basis to assess effectiveness and ensure pupils are kept safe from potentially harmful and inappropriate content and contact online while at school, including terrorist and extremist material
- Ensuring that the school's ICT systems are secure and protected against viruses and malware, and that such safety mechanisms are updated regularly
- Conducting a full security check and monitoring the school's ICT systems
- Blocking access to potentially dangerous sites and, where possible, preventing the downloading of potentially dangerous files

#### 3.5 All staff and volunteers

All staff, including contractors and agency staff, and volunteers are responsible for:

- Maintaining an understanding of this policy
- Implementing this policy consistently
- Agreeing and adhering to the terms on acceptable use of the school's ICT systems and the internet (Appendix 4), and ensuring that pupils follow the school's terms on acceptable use (Appendices 1, 2 and 3)
- Ensuring that any incidents of cyber-bullying are dealt with appropriately in line with the school behaviour policy
- Responding appropriately to all reports and concerns about sexual violence and/or harassment, both online and offline and maintaining an attitude of 'it could happen here'

#### 3.6 Parents

Parents are expected to:

- Notify a member of staff or the headteacher of any concerns or queries regarding this policy
- Ensure their child has read, understood and agreed to the terms on acceptable use of the school's ICT systems and internet (Appendices 1, 2 and 3)

Parents can seek further guidance on keeping children safe online from the organisations and websites identified on the school website.

## 3.7 Visitors and members of the community

Visitors and members of the community who use the school's ICT systems or internet will be made aware of this policy, when relevant, and expected to read and follow it. If appropriate, they will be expected to agree to the terms on acceptable use (Appendix 4).

## 4. Educating pupils about online safety

Pupils will be taught about online safety as part of the curriculum:

The text below is taken from the National Curriculum computing programmes of study.

It is also taken from the guidance on relationships education, relationships and sex education (RSE)

and health education. We also have a statutory requirement to teach:

• Relationships education and health education in

primary schoolsIn **Key Stage 1**, pupils will be taught to:

- Use technology safely and respectfully, keeping personal information private
- Identify where to go for help and support when they have concerns about content or contact on the internet or other onlinetechnologies

Pupils in Key Stage 2 will be taught to:

- Use technology safely, respectfully and responsibly
- Recognise acceptable and unacceptable behavior
- Identify a range of ways to report concerns about content and contact

By the end of primary school, pupils will know:

- That people sometimes behave differently online, including by pretending to be someone they are not
- That the same principles apply to online relationships as to face-to-face relationships, including the importance of respect for others online including when we are anonymous
- The rules and principles for keeping safe online, how to recognise risks, harmful content and contact, and how to report them
- How to critically consider their online friendships and sources of information including awareness of the risks associated with people they have never met
- How information and data is shared and used online
- What sorts of boundaries are appropriate in friendships with peers and others (including in a digital context)
- How to respond safely and appropriately to adults they may encounter (in all contexts, including online) whom they do not know

The safe use of social media and the internet will also be covered in other subjects where relevant.

Where necessary, teaching about safeguarding, including online safety, will be adapted for vulnerable children, victims of abuseand some pupils with SEND.

## 5. Educating parents about online safety

The school will raise parents' awareness of internet safety in letters or other communications home e.g. our Safeguarding Newsletter, and in information via our website (policy on school website).

If parents have any queries or concerns in relation to online safety, these should be raised in the first instance with theheadteacher and/or the DSL.

## 6. Cyber-bullying

#### 6.1 Definition

Cyber-bullying takes place online, such as through social networking sites, messaging apps or gaming sites. Like other forms of bullying, it is the repetitive, intentional harming of one person or group by another person or group, where the relationship involves an imbalance of power.

#### 6.2 Preventing and addressing cyber-bullying

To help prevent cyber-bullying, we will ensure that pupils understand what it is and what to do if they become aware of it happening to them or others. We will ensure that pupils know how they can report any incidents and are encouraged to do so, including where they are a witness rather than the victim.

The school will actively discuss cyber-bullying with pupils, explaining the reasons why it occurs, the forms it may take and whatthe consequences can be. Class teachers will discuss cyber-bullying with their classes.

All staff, governors and volunteers (where appropriate) receive training on cyber-bullying, its impact and ways to support pupils, as part of annual safeguarding training.

The school also sends information/leaflets on cyber-bullying to parents so that they are aware of the signs, how to report it and how they can support children who may be affected.

In relation to a specific incident of cyber-bullying, the school will follow the processes set out in the school's behaviour policy. Where illegal, inappropriate or harmful material has been spread among pupils, the school will use all reasonable endeavours to ensure the incident is contained.

The DSL will consider whether the incident should be reported to the police if it involves illegal material,

and will work with external services if it is deemed necessary to do so.

### 6.3 Examining electronic devices

The headteacher, and any member of staff authorised to do so by the headteacher can carry out a search and confiscate any electronic device that they have reasonable grounds for suspecting:

- Poses a risk to staff or pupils, and/or
- Is identified in the school rules as a banned item for which a search can be carried out, and/or
- Is evidence in relation to an offence

Before a search, the authorised staff member will:

- Make an assessment of how urgent the search is, and consider the risk to other pupils and staff
- Explain to the pupil why they are being searched, how the search will happen, and give them the opportunity to askquestions about it
- Seek the pupil's cooperation

Authorised staff members may examine, and in exceptional circumstances erase, any data or files on an electronic device that they have confiscated where they believe there is a 'good reason' to do so.

When deciding whether there is a 'good reason' to examine data or files on an electronic device, the staff member should reasonably suspect that the device has, or could be used to:

- Cause harm, and/or
- Undermine the safe environment of the school or disrupt teaching, and/or
- · Commit an offence

If inappropriate material is found on the device, it is up to the headteacher or DSL (or deputy DSL) to decide on a suitable response. If there are images, data or files on the device that staff reasonably suspect are likely to put a person at risk, they will first consider the appropriate safeguarding response.

When deciding if there is a good reason to erase data or files from a device, staff members will consider if the material may constitute evidence relating to a suspected offence. In these instances, they will not delete the material and the device will be handed to the police as soon as reasonably practicable. If the material is not suspected to be evidence in relation to an offence, staff members may delete it if:

- They reasonably suspect that its continued existence is likely to cause harm to any person, and/or
- The pupil and/or the parent refuses to delete the material themselves

If a staff member suspects a device may contain an indecent image of a child (also known as a nude or semi-nude image), they will:

- Not view the image
- Confiscate the device and report the incident to the DSL (or equivalent) immediately, who will
  decide what to do next. The DSL will make the decision in line with the DfE's latest guidance on
  screening, searching and confiscation and the UK Council for Internet Safety (UKCIS) guidance on
  sharing nudes and semi-nudes: advice for education settings working with children and young
  people

Any searching of pupils will be carried out in line with:

- The DfE's latest guidance on searching, screening and confiscation
- UKCIS guidance on sharing nudes and semi-nudes: advice for education settings working with children and young people

Our behaviour policy (section titled Confiscating inappropriate items)

Any complaints about searching for or deleting inappropriate images or files on pupils' electronic devices will be dealt with through the school complaints procedure.

# 7. Acceptable use of the internet in school

All pupils, parents, staff, volunteers and governors are expected to read and sign an agreement regarding the acceptable use of the school's ICT systems and the internet (Appendices 1-4). Visitors will be expected to read and agree to the school's terms on acceptable use if relevant.

Use of the school's internet must be for educational purposes only, or for the purpose of fulfilling the duties of an individual's role.

We will monitor the websites visited by pupils, staff, volunteers, governors and visitors (where relevant) to ensure they complywith the above.

#### 8. Pupils using mobile devices in school

Pupils may bring mobile devices into school only where this has been agreed as part of their walk home alone risk assessment. The agreed procedure is:

The mobile phone needs to be switched off prior to children entering the school grounds;

The device must be handed to an adult and will be kept in the office until the end of the day and will be returned to the child at the end of the school day,

The mobile phone must only be switched on once the child has left the school grounds.

Where there is unacceptable use of a mobile phone, it could lead to a review of the risk assessment and a decision made where the child is no longer allowed to bring a mobile phone to school.

# 9. Staff using work devices outside school

All staff members will take appropriate steps to ensure their devices remain secure. This includes, but is not limited to:

- Keeping the device password-protected strong passwords are encouraged
- Ensuring their hard drive is encrypted this means if the device is lost or stolen, no one can access the files stored on the hard drive by attaching it to a new device
- Making sure the device locks if left inactive for a period of time
- Not sharing the device among family or friends
- Installing anti-virus and anti-spyware software
- Keeping operating systems up to date always install the latest updates

Staff members must not use the device in any way which would violate the school's terms of acceptable use, as set out in Appendix 4.

Work devices must be used solely for work activities.

If staff have any concerns over the security of their device, they must seek advice from the ICT manager.

#### 10. How the school will respond to issues of misuse

Where a pupil misuses the school's ICT systems or internet, we will follow the procedures set out in our Behaviour and Anti- Bullying policy. The action taken will depend on the individual circumstances, nature and seriousness of the specific incident, and will be proportionate.

Where a staff member misuses the school's ICT systems or the internet, or misuses a personal device where the action constitutes misconduct, the matter will be dealt with in accordance with the staff code of conduct. The action taken will depend on the individual circumstances, nature and seriousness of the specific incident.

The school will consider whether incidents which involve illegal activity or content, or otherwise serious incidents, should be reported to the police.

### 11. Training

All new staff members will receive training, as part of their induction, on safe internet use and online safeguarding issues including cyber-bullying and the risks of online radicalisation.

All staff members will receive refresher training as part of safeguarding training, as well as relevant updates as required (for example through emails, e-bulletins and staff meetings).

By way of this training, all staff will be made aware that:

Technology is a significant component in many safeguarding and wellbeing issues, and that children are at risk of online abuse. Children can abuse their peers online through:

- Abusive, harassing, and misogynistic messages
- Non-consensual sharing of indecent nude and semi-nude images and/or videos, especially around chat groups
- Sharing of abusive images and pornography, to those who don't want to receive such content Physical abuse, sexual violence and initiation/hazing type violence can all contain an online element Training will also help staff:
  - develop better awareness to assist in spotting the signs and symptoms of online abuse
  - develop the ability to ensure pupils can recognise dangers and risks in online activity and can weigh the risks up
  - develop the ability to influence pupils to make the healthiest long-term choices and keep them safe from harm in the short term

The DSL and deputies will undertake child protection and safeguarding training, which will include online safety, at least every 2 years. They will also update their knowledge and skills on the subject of online safety at regular intervals, and at least annually.

Governors will receive training on safe internet use and online safeguarding issues as part of their safeguarding training. Volunteers will receive appropriate training and updates, as applicable.

More information about safeguarding training is set out in our Safeguarding and Child Protection policy.

#### 12. Monitoring arrangements

The DSL records behaviour and safeguarding issues related to online safety. (Placed on CPOMs)

This policy will be reviewed every year by the DSL. At every review, the policy will be shared with the governing body. This is important because technology, and the risks and harms related to it, evolve and change rapidly.

I will immediately let a teacher or other member of staff know if I find any material which might upset, distress or harm me orothers.

I will always use the school's ICT systems and internet responsibly.

I understand that the school can discipline me if I do certain unacceptable things online, even if I'm not in school when I do them

# E-Safety Rules for EYFS and KS1 Pupils

The school has installed computers and mobile devices with Internet access to help with my learning. These rules will keep me safe and help me be fair to others.

I will use school computers for school work and not to upset or be rude to other people.  I will look after school ICT equipment and tell a teacher straight away if something is broken or not working properly.  I will log off or shut down a computer when I have finished using it.
I will save only school work on a school computer and will check with my teacher before printing.
I will always use what I have learned about e-safety to keep myself safe and will tell a teacher if something makes me worried or unhappy.
I will not open emails from people I don't know without checking with my teacher.  I will write polite and friendly emails to people that I know including any messages I send.
I will only use the Internet when an adult is with me.  I will only go on websites that an adult has found for me.  I will tell my teacher straight away if I go on a website by mistake.

# E-Safety Rules for KS2 Pupils

The school has installed computers and mobile devices with Internet access to help with my learning. These rules will keep me safe and help me be fair to others.

- I will always use what I have learned about e-safety to keep myself safe and will tell a teacher if something makes me worried or unhappy.
- I will only use school ICT equipment for my school work and not to upset or bully other people or create a bad impression of my school.
- I will take responsibility for my own use of all ICT equipment and will use it safely, responsibly and legally e.g.
  - I will only use my school email account (which ends .sch.uk) in school
  - I will not open any email attachments without checking with an adult
  - I will make sure that my work does not break copyright
- I will not go on any unsuitable or illegal web sites. If I go on any by mistake I will tell my teacher straight away.
- 1 will tell a teacher if I can see a website that is inappropriate or receive any unwanted email.
- 1 will look after school ICT equipment and report any damage to a teacher straight away.
- 1 will use the usernames and passwords I have been given and I will keep them secret.
- 1 will only log on to my accounts and not try to access those of someone else.
- I will only look at or delete my own files and only save school work on the school network. I will check with my teacher before printing.
- 1 will not use memory sticks in school equipment.
- I will only e-mail people I know, or my teacher has approved and the messages I send will be polite and responsible.
- 1 understand that I must never give my home address or phone number, or arrange to meet someone.
- 1 will not use Internet chat or social networking sites.
- 1 will log off or shut down a computer when I have finished using it.
- 1 understand that the school may check my computer files and the Internet sites I visit.
- 1 understand that if I deliberately break these rules, I may not be allowed to use the Internet or computers
